In its FIRST CLAIM FOR RELIEF, for the principal sum of \$9,587.90, with interest thereon at 12.00% per annum from and after July 31, 1990 until paid; for costs of Court and attorneys' fees from the prior judgment in the sum of \$1,502.57; for accrued interest in the sum of \$5,391.89; for the costs of this action, to be taxed by the Clerk; and

b. In its SECOND CLAIM FOR RELIEF, for the principal sum of \$9,224.01, with interest thereon at 14.00% per annum from and after November 4, 1990 until paid; for accrued interest in the sum of \$12,039.73; for costs of Court and attorneys' fees from the
