


**ARTICLES OF MERGER

**PURSUANT TO ARTICLE 10 OF THE ALABAMA LIMITED LIABILITY
COMPANY ACT**, the undersigned, being the manager of Dispatch Technologies, LLC, an Alabama domestic limited liability company and the surviving company, and the manager of Dispatch Technologies, LLC (Nevis), the company being merged, adopt the following Articles of Merger.

1. The Articles of Organization of Dispatch Technologies, LLC, an Alabama domestic limited liability company and the surviving company, were filed with the Probate Judge of Shelby County, Alabama, as of the 31st day of December, 1998.
2. The Articles of Organization of Dispatch Technologies, LLC (Nevis), the company being merged, were filed with the Nevis Registrar of Companies as of the 31st day of January, 1997.
3. The merger set forth above was duly approved by the members of each constituent company, respectively, in compliance with the applicable provisions of the Alabama Limited Liability Company Act and the Nevis Limited Liability Company Ordinance 1995.
4. The name of the surviving domestic limited liability company is Dispatch Technologies, L.L.C. (the "Company").
5. The effective date of the merger shall be after the close of business of the Company on December 31, 1998.
6. The Agreement of Merger is on file at the place of business of the surviving domestic limited liability company. The address of the place of business for the Company is 406 Cahaba Valley Circle, Pelham, Alabama 35124.
