KNOW ALL MEN BY THESE PRESENTS, That in consideration of ONE HUNDRED FORTY-SIX THOUSAND NINE HUNDRED DOLLARS AND NO/100's (\$146,900.00) to the undersigned grantor, H.P.H. PROPERTIES, INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto ROBERT PITTMAN LANE and JANET ANN LANE (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:
