- 14. DEFAULT. Mortgagor will be in default if any party obligated on the Secured Debt fails to make payment when due Mortgagor will be in default if a breach occurs under the terms of this Security Instrument or any other document executed for the purpose of creating, securing or guarantying the Secured Debt.
