ORDER

THIS CAUSE came on to be heard on the 24th day of March, 1997, on remand from the Court of Civil Appeals of Alabama for the purpose of calculating the amount of the claim allowable against the Estate of Garland Edward Baucom by Mary B. Smith. Both parties having appeared at said hearing with their respective attorneys of record, and based upon the stipulation of the parties that the sum of Twenty Three Thousand Seventy Five and No/100 (\$23,075.00) Dollars in Social Security payments paid to Mary B. Smith on the account of Garland Edward Baucom, deceased, for the minor child, Melanie Paige Baucom, are due to be applied as a credit toward the total amount due for past due child support payments, and based upon the further stipulation of the parties that the remaining balance due for past due child support payments after applying said credits is the sum of Seventeen Thousand Seven Hundred Fifty Six and No/100 (417,756.00) Dollars, and the Court, having considered

same, the Court is of the opinion that the following Order should be entered. Accordingly, it is,


ORDERED and ADJUDGED by the Court as follows:

1. That the sum of Twenty Three Thousand Seventy Five and No/100 (\$23,075.00) Dollars in Social Security payments paid to Mary B. Smith on the account of Garland Edward Baucom, deceased, for the minor child, Melanie Paige Baucom, are due to be applied as a credit toward the total amount due for past due child support payments. That the remaining balance due for past due child support payments after applying said credits is Seventeen Thousand Seven Hundred Fifty Six and No/100 (\$17,756.00) Dollars.

2. That the claim of Mary B. Smith in the amount of Seventeen Thousand Seven Hundred Fifty Six and No/100 (\$17,756.00) Dollars is hereby allowed against the Estate of Garland Edward Baucom.

5. That the costs of court are hereby taxed against the Plaintiff.

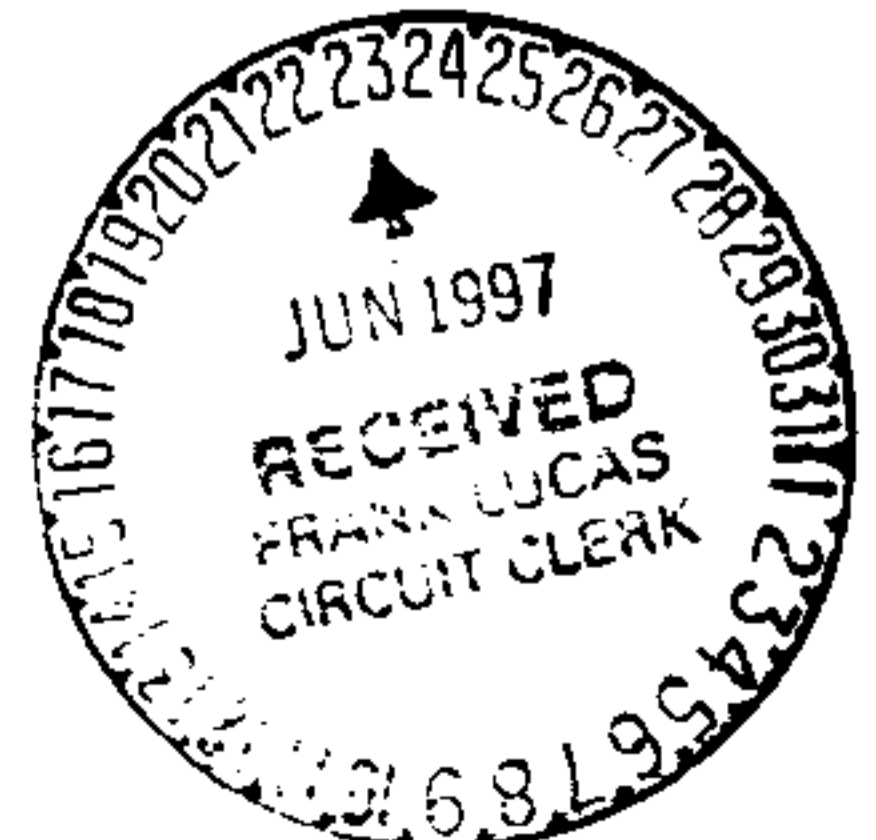
