## SUBORDINATION AGREEMENT

THIS AGREEMENT is made and entered into on this 21 day of JANUARY, 1999 by COMPASS BANK (hereinafter referred to as the "Mortgagee") in favor of NORWEST MORTGAGE, INC., its successors and assigns (hereinsiter referred to as "NMI").

## WITNESSETH

WHEREAS, NMI has agreed to make the Loan to the Borrower, if, but only if, the New Mortgage shall be and remain a lien or charge upon the property covered thereby proper and superior to the lien or charge of the Mortgage and provided that the Mortgages will specifically and unconditionally subordinate the lien or charge of the Mortgage to the lien or charge of the New Mortgage of NMI:

NOW, THEREFORE, in consideration of one dollar and in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of all of which is hereby acknowledged, and in order to induce NMI to make the Loan above referried to, Mortgagee agrees as follows:

- 1. The New Mortgage and the note secured thereby and the debt evidenced by such note and any and all renewals and extensions thereof, or of any part thereof and all interest payable on all of said debt and on any and all such renewals and extensions shall be and remain at all times a lien or charge on the property covered by the New Mortgage, prior and superior to the lien or charge of the Mortgage in favor of Mortgages.

Mortgages acknowledges that it intentionally waives, relinquishes, and subordinated the priority and superiority of the lien or charge of the Mortgage in favor of the lien of charge of the New Mortgage in favor of NMI, and that it understands that in reliance upon and in consideration of this waiver, relinquishment, and subordination specific lourie and advances are being and will be made, and as pert and percel thereof specific monetary and other obligations are being and will be entered into by NMI which would not be made or entered into but for such reliance upon this waiver. relinquishment, and subordingtion.
