AMENDED EASEMENT FOR SURFACE WATER DRAINAGE

This Amended Easement for Surface Water Drainage is made as of the Zo day of JANUARY, 1998, by and between Storage USA SING, LLC, a Maryland limited liability company (hereinafter "SING") and GREY SHOAL, LLC, an Alabama limited liability company (hereinafter "Grey Shoal").

RECITALS:

An Easement recorded in Instrument # 1998-18978, in the Office of the Judge of Probate of Shelby County, Alabama was granted for surface water drainage in favor of Grey Shoal, its heirs, successors and assigns. Said Easement encumbered Lot 2 of the Regions Bank at 280 Survey recorded in Map Book 23, Page 40, Shelby County, Alabama (the "Property"). SING has consummated the purchase the Property and is constructing a self-storage facility on the Property. During construction, it was determined that the location of the easement needs to be amended in order to properly place the drainage structure which will drain water from certain parts of property owned by Grey Shoal toward and through the Property. SING and Grey Shoal hereby agree to the amend the easement as follows:

AGREEMENT

NOW THEREFORE, in consideration of the above and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties to this Agreement agree as follows:

- 1. SING reaffirms its grant of a non-exclusive, perpetual easement for drainage, discharge, and flowage of surface water from the portion of property used by Grey Shoal over, through and across the Property; however, the location of said easement has been amended and is described on Exhibit 1 attached hereto.
- 2. SING is constructing and installing a drainage system in the easement which is sized in such manner so as to carry the surface water from the property owned by Grey Shoal through said drainage system. The discharge of water so collected in the drainage system is being located at a point and in an area where the surface water would have naturally and normally collected before the construction of the drainage system.
 - 3. It is understood that this easement is for the drainage of surface water only.
- 4. The easement granted herein shall be for the non-exclusive use and benefit of Grey Shoal, its successors and assigns, and shall run with the land.
