KNOW ALL MEN BY THESE PRESENTS, That in consideration of ONE HUNDRED FORTY-NINE THOUSAND NINE HUNDRED AND NO/100 DOLLARS (\$149,900.00) to the undersigned grantor, H. P. H. PROPERTIES, INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto DAVID R. CAROTHERS and DEE ANN CAROTHERS (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in Shelby County, Alabama:

A, a resurvey of Lots 310, 311 and 312
