**SIXTH AMENDMENT TO
CERTIFICATE AND LIMITED PARTNERSHIP AGREEMENT**

The undersigned, desiring to amend the Certificate and Limited Partnership Agreement (the "Certificate") of CHELSEA FARM PARTNERSHIP, LTD. (the "Partnership"), dated as of July 30, 1993, and filed on August 5, 1993 in the Judge of Probate of Shelby County, Alabama, in Inst #1993-23134, do hereby make, sign and file the following Sixth Amendment to the Certificate as of March 15, 1998. Unless otherwise indicated, all capitalized terms shall have the meanings set forth in the Certificate.

1. The name of the Partnership is Chelsea Farm Partnership, Ltd.
2. The Partnership was organized as of July 30, 1993, pursuant to the Certificate described above which was filed on August 5, 1993.
3. As a result of additional property contributed to the Partnership by Laurence D. Weygand, the percentage ownership of the Partnership is hereby adjusted and the Certificate is hereby amended by deleting Section 2.02 thereof in its entirety and substituting in lieu thereof the following:

Section 2.02 - Partnership Interests

In consideration of their capital contributions, the Partners shall have the following percentage interests in the Partnership (individually a "Percentage Interest" and jointly the "Percentage Interests"):




5. The Partners hereby confirm, ratify and approve the terms and provisions of the Certificate, including all previous amendments thereto.
