KNOW ALL MEN BY THESE PRESENTS. That in consideration of **THREE HUNDRED THIRTY-NINE THOUSAND TWO HUNDRED FOURTEEN AND 09/100's DOLLARS (\$339,214.09)** to the undersigned grantor, ROBERT S. GRANT CONST., INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto **JAIME R. ASTORGA and NANCY L. ASTORGA** (herein referred to as GRANTEEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:

Lot 812, according to the Map of Highland Lakes, 8th Sector, an Eddleman Community, as recorded in Map Book 23, Page 145, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.
