KNOW ALL MEN BY THESE PRESENTS, That in consideration of **SIX HUNDRED THIRTY-FIVE THOUSAND DOLLARS AND NO/100's (\$635,000.00)** to the undersigned grantor, CROWN CONSTRUCTION CO., INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto **F. DANIEL THOMAS and TONYA THOMAS** (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:
