**WARRANTY DEED: JOINT TENANCY
WITH RIGHT OF SURVIVORSHIP**

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of One Hundred and Twenty-Five Thousand Dollars & 00/100 dollars (\$125,000.00) and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, that, Inez Lester Lacey, a single person, hereinafter called "Grantors", do hereby GRANT, BARGAIN, SELL AND CONVEY unto Derek S. Jones, and his wife, Connie L. Jones, hereinafter called "Grantees" for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to wit:

Lot #3, in Block Q, of Lyman's Addition to the Town of Montevallo, as recorded in Map Book 3, Page 27, in the Probate Office of Shelby County, Alabama.

TO HAVE AND TO HOLD to the said Grantees in fee simple forever, for and during their joint lives and upon the death of either of them, then the survivor in fee simple, and to the heirs of such survivor forever, together with every contingent remainder and right of reversion.
