KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Seventy-Two Thousand Nine Hundred and no/100 Dollars (\$ 172,900.00) and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, MARCUS L. HICKSON, III & NANCY DORMAN-HICKSON, HUSBAND & WIFE, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto JOHN W. BUTTREY, JR. & JULIE B. BUTTREY, (herein referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 827, according to the Survey of Fifteenth Addition to Riverchase Country Club, as recorded in Map Book 8, page 168, in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way of record; taxes for 1999 and subsequent years not yet due and payable.
