- 6. CONSTRUCTION MORTGAGE. I If checked, this Mortgage is a construction mortgage that secures an Obligation incurred for the acquisition cost of the land and/or the construction of an improvement on land, and it will be subject to the terms of a construction loan agreement between Mortgagor and Lender. Any materials, equipment or supplies used or intended for use in the construction, development or operation of the Property. whether stored on or off the Property, shall also be subject to the lien of this Mortgage. Mortgager shall obtain Lender's approval of all plans and specifications, and no changes to the plans and specifications or the nature of the construction project shall be permitted without the prior written approval of Lender.
- 7. LEASES AND OTHER AGREEMENTS. Mortgagor shall not take or fail to take any action which may cause or permit the termination or the withholding of any payment in connection with any Lease pertaining to the Property. In addition, Mortgagor, without Lender's prior written consent, shall not: (a) collect any monies payable under any Lease more than one month in advance; (b) modify any Lease; (c) assign or allow a lien, security interest or other encumbrance to be placed upon Mortgagor's rights, title and interest in and to any Lease or the amounts payable thereunder; or (d) terminate or cancel any Lease except for the nonpayment of any sum or other material breach by the other party thereto. If Mortgagor receives at any time any written communication asserting a default by Mortgagor under an Lease or purporting to terminate or cancel any Lease, Mortgagor shall promptly forward a copy of such communication (and any subsequent communications relating therein) to Lentler. All such Leases and the amounts due to Mortgagor thereunder are hereby assigned to Londer as additional security for the Obligations.
- 8. COLLECTION OF INDESTEDNESS FROM THIRD PARTY. Leader shall be entitled to notify or require Moragagor to notify any third party (including, but not limited to, lessess, licensess, governmental authorities and insurance companies) to pay Lender any indebtedness or obligation owing to Mortgagor with respect to the Property (cumulatively "ladebtedness") whether or not a default exists under this Mortgage. Mortgagor shall diligently collect the Indebtedness owing to Mortgagor from these third parties until the giving of such notification. In the event that Mortgagor possesses or receives possession of any instruments or other remissiones with respect to the Indebtedness following the giving of such nonfication of if the instruments or other remittances constitute the propayment of any indebtedness or the payment of any insurance or condemnation proceeds, Mortgagor shall hold such instruments and other resultances in trust for Lender apart from its other property, endorse the instruments and other remittances to Lender, and immediately provide Lender with possession of the instruments and other remittances. - 9. USE AND MAINTENANCE OF PROPERTY. Mortgagor shall take all actions and make any repairs needed to maintain the Property in good condition. Mortgagor shall not commit or permit any waste to be committed with respect to the Property. Mortgagor shall use the Property solely in compliance with applicable law and insurance policies. Mortgagor shall not make any alterations, additions or improvements to the Property without Leader's prior written consent. Without limiting the foregoing, all alterations, additions and improvements made to the Property shall be subject to the beneficial interest belonging to Lender, shall not be removed without Lender's prior written consent, and shall be made at Mortgagor's sole expense.
- 20. LOSS OR DAMAGE. Mortgagor shall bear the entire risk of any loss, theft, destruction or damage (cumulatively "Loss or Damage") to the Property or any portion thereof from any cause whatsoever. In the event of any Loss or Damage, Mortgagor shall, at the option of Lender, repair the affected Property to its previous condition or pay or cause to be paid to Lender the decrease in the fair market value of the affected Property
- II. INSURANCE. The Property will be kept insured for its full insurable value against all loss or damage caused by flood, earthquake, tornado and fire, theft or other casualty to the extent required by Lender. MORTGAGOR HAS THE RIGHT TO PROVIDE SUCH INSURANCE THROUGH AN EXISTING POLICY OR A POLICY INDEPENDENTLY OBTAINED AND PAID FOR BY MORTGAGOR, subject to the right of Lender to decline the insurance offered by Mortgagor for reasonable cause before credit is extended. The insurance policies shall require the insurance company to name Lender as a loss payor and provide that no act or omission of Mortgagor or any other person shall affect the right of Lender to be paid the insurance proceeds pertaining to the loss or damage of the Property. In the event Mortgagor fails to acquire or maintain insurance, Lender (after providing notice as may be required by law) may in its discretion procure appropriate insurance coverage upon the Property and the insurance cost shall be an advance payable and bearing interest as described in Paragraph 22 and secured hereby. Mortgagor shall furnish Lender with evidence of insurance indicating the required coverage. Lender may act as attorney-in-fact for Mortgagor in making and setting claims under insurance policies, cancelling any policy or endorsing. Mortgagor's name on any draft or negotiable instrument drawn by any insurer. Altsuch insurance policies shall be immediately assigned, pledged and delivered to Leader as further security for the Obligations. In the event of loss, Mortgagor shall immediately give Lender written notice and Lender is suthorized to make proof of loss. Each insurance company is directed to make payments directly to Lender instead of to Lender and Mortgagor. Any amounts may at Lender's option be applied in the inverse order of the due dates thereof.
- 12. ZONING AND PRIVATE COVENANTS. Mortgagor shall not initiate or consent to any change in the zoning provisions or private covenants affecting the use of the Property without Lender's prior written consent. If Mortgagor's use of the Property is or becomes a nonconforming use under any zoning provision. Mortgagor shall not cause or permit such use to be discontinued or abundoned without the prior written consent of Lender Mortgagor will immediately provide Lender with written notice of any proposed changes to the zoning provisions or private covenants affecting the Property.
- 13. CONDEMNATION. Mortgagor shall immediately provide Lender with written notice of any actual or threatened condemnation or eminent domain proceeding pertaining to the Property. All monies payable to Mortgagor from such condemnation or taking are hereby assigned to Lender and shall be applied first to the payment of Lender's attorneys' fees, legal expenses and other costs (including appraisal fees) in connection with the condemnation or eminent domain proceedings and then, at the option of Lender, to the payment of the Obligations or the restoration or repair of the Property.
- 14. LENDER'S RIGHT TO COMMENCE OR DEFEND LEGAL ACTIONS. Morgagor shall immediately provide Lender with written notice of any actual or threatened action, suit, or other proceeding affecting the Property. Mortgagor hereby appoints Lender as its attorney-in-fact to commence. intervene in, and defend such actions, suits, or other legal proceedings and to compromise or settle any claim or controversy pertaining thereto Lender shall not be liable to Mortgagor for any action, error, mistake, omission or delay permining to the actions described in this paragraph or any damages resulting therefrom. Nothing contained herein will prevent Lender from taking the actions described in this paragraph in its own name
- 15. INDEMNIFICATION, Lender shall not assume or be responsible for the performance of any of Mortgagor's obligations with respect to the Property under any circumstances. Mortgagor shall immediately provide Lender with written notice of and indemnify and hold Lender and its shareholders, directors, officers, employees and agents harmless from all claims, damages, liabilities (including attorneys' fees and legal expenses), causes of action, actions, suits and other legal proceedings (cumulatively "Claims") pertaining to the Property (including, but not limited to those involving Hazardous Materials). Mortgagor, upon the request of Lender, shall hire legal counsel to defend Lender from such Claims, and pay the attorneys' fees, legal expenses and other costs incurred in connection therewith. In the alternative, Lender shall be entitled to employ its own legal counsel to defend such Claims at Mortgagor's cost, Mortgagor's obligation to indemnify Lender under this paragraph shall survive the termination. release or foreclosure of this Mortgage.
- 16. TAXES AND ASSESSMENTS. Mortgagor shall pay all taxes and assessments relating to the Property when due and immediately provide Lender evidence of payment of some. Upon the request of Lender, Mortgagor shall deposit with Lender each month one-twelfth (1/12) of the estimated annual insurance premium, taxes and assessments pertaining to the Property. So long as there is no default, these amounts thall be applied to the payment of taxes, assessments and insurance as required on the Property. In the event of default, Lender shall have the right, at its sole option, to apply the funds so held to pay any taxes or against the Obligations. Any funds applied may, at Lender's option, he applied in reverse order of the due date thereof.

17. INSPECTION OF PROPERTY, BOOKS, RECORDS AND REPORTS. Movingsor shall allow Londor or its agents to examine and inspect the Property and examine, inspect and make copies of Mortgagor's books and seconds pertaining to the Property from time to time. Mortgagor shall provide any assistance required by Lender for these purposes. All of the eigensteres and information contained in Moragagor's books and records shall be genuine, true, accurate and complete in all respects. Montgagor shall note the existence of Lander's beneficial interest in its books and records permining to the Property. Additionally, Mortgagor shall report, in a form satisfactory to Lender, such information as Lender may requiest regarding Mortgagor's funccial condition or the Property. 18. ESTOFFEL CERTIFICATES. Within ten (10) days after any request by Lander, Mortgagor shall deliver to Londer, or any intended transfered of Londor's rights with respect to the Obligations, a signed and acknowledged statement specifying: (a) the outstanding balance on the Obligations, and (b) whether Mortgagor possesses any claims, defenses, set-offs or counterclaims with respect to the Obligations and, if so, the nature of such claims, defenses, set-offs or counterclaims. Moragagor will be conclusively bound by any representation that Lender may make to the instanced

transferor with respect to these matters in the event that Moragagor fails to provide the requested statuement in a timely manner.

19. EVENTS OF DEFAULT. As Breat of Default will occur under this Mortgage in the event that Mortgagor, Borrower or any guaranter of the Obligation: (a) falls to pay any Obligation to Lender when due:

(b) fails to perform any Obligation or breaches any warranty or covernet to Lender contained in this Mortgage or any other present or featre (c) destroys, loses or damages the Property in any material respect or subjects the Property to seizure, confiscation, or condemnation; agreement:

(d) seeks to revoke, terminate or otherwise limit in Hability under any guaranty to Lender or any individual guaranter dies; (e) dies, becomes legally incompetent, is dissolved or terminated, becomes insolvent, makes an assignment for the benefit of creditors, fasts to pay debts as they become due, files a petition under the federal bankruptcy laws, has an involuntary petition in bankruptcy filed in which Mortgagor, Borrower or any guarantor is named, or has property taken under any writ or process of court;

(f) allows goods to be used, transported or stored on the Property, the possession, transportation, or use of which, is illegal;

- (g) allows any party other than Mortgagor or Borrower to sessence or undertake any Obligation without the written consent of Lender; or (h) courses Lender to deem itself insecure dee to a significant decline in the value of the Property; or if Lender, in good faith, believes for any means that the prospect of payment or performance is impaired.
- 20. RIGHTS OF LENDER ON EVENT OF DEFAULT. Upon the occurrence of an Event of Default under this Mortgage. Lender shall be entitled to exercise one or more of the following remedies without notice or demand (except as required by law):

(a) to declare the Obligations immediately due and payable in full, such acceleration to be automatic and immediate if the Event of Default is a filing under the Bankruptcy Code:

(b) to collect the outstanding Obligations with or without recording to judicial process;

(c) to require Mortgagor to deliver and make available to Londer any personal property or Chattels constituting the Property at a place reasonably convenient to Mortgagor and Lender; (d) to enter upon and take possession of the Property without applying for or obtaining the appointment of a receiver and, at Londer's option, to

appoint a receiver without bond, without first bringing suit on the Obligations and without otherwise meeting any statutory conditions regarding receivers, it being intended that Lender shall have this contractual right to appoint a receiver;

(a) to employ a managing agent of the Property and let the same, in the name of Lender or in the name of Mortgagor, receive the rents. incomes, issues and profits of the Property and apply the same, after payment of all necessary charges and expenses, on account of the

(f) to pay any sums in any form or manner deemed expedient by Lender to protect the security of this Mortgage or to cure any default other

than payment of interest or principal on the Obligations; (g) to foreclose this Mortgage under the power of sale and in accordance with the requirements of law or by judicial action, at Lender's election;

successors in title of Mortgagor in the Property. 22. REIMBURSEMENT OF AMOUNTS EXPENDED BY LENDER. Lender, at Lender's option, may expend funds (including attorneys' fees and legal expenses) to perform any act required to be taken by Mortgagor or to exercise any right or remedy of Lender under this Mortgage. Upon demand, Mortgagor shall immediately reimburse Londer for all such amounts expended by Lender together with interest thereon at the lower of the highest rate described in any Obligation or the highest rate allowed by law from the date of payment until the date of reimbursement.
