EXHIBIT "A" LEGAL DESCRIPTION

PARCEL I: A parcel of land situated in the NE 1/4 of the NW 1/4 of Section 25, Township 19 South. Range 3 West, described as follows: Beginning at the SE corner of the NE 1/4 of the NW 1/4 of said Section 25 and go North 00 degrees 00 minutes 00 seconds West along the Bast boundary of said Section 25 and the West boundary of the Riverchase West Subdivision, Second Addition, Map Book 7, page 59, and the West boundary of the Highlands at Riverchase, Map Book 23, Page 8, for 562.55 feet; thence North 89 degrees 15 minutes 44 seconds West along the South boundary of The Highlands at Riverchase for 572.09 feet, measured (map 576.10 feet); thence continue North 89 degrees 15 minutes 44 seconds West for 186.51 feet; thence South 00 degrees 45 minutes 54 seconds East for 149.35 feet; thence South 89 degrees 28 minutes 48 seconds East for 417.40 feet; thence South 13 degrees 06 minutes 39 seconds West for 427.42 feet; thence South 07 degrees 15 minutes 00 seconds West for 43.91 feet to the North boundary of the Old Montgomery Highway; thence two courses (2) along said North boundary as follows: go South 82 degrees 45 minutes 15 seconds East for 221.13 feet to the beginning of a curve to the right, having a central angle of 21 degrees 20 minutes 40 seconds and a radius of 458.10 feet; thence Southeasterly along said curve for 170.66 feet; thence North 26 degrees 44 minutes 35 seconds East for 135.23 feet to the point of beginning.
