- 10. Borrower Not Released; Forbearance By Lender Not a Waiver. Lender shall not be required to commence proceedings against such successor or refuse to extend time tot payment or otherwise modify amortization of the sums secured by this Mortgage by reason of any demand made by the original Borrower and Borrower's successors in interest. Any forbearance by Lender in exercising any right or temedy hereunder, or otherwise afforded by applicable law, shall not be a waiver of or preclude the exercise of any such right or remedy.

- 12. Notice. Except for any notice required under applicable law to be given in another manner.
