

**ARTICLES OF ORGANIZATION
OF
TSG CONSTRUCTION, L.L.C.**

Pursuant to the Provisions of Act No. 93-724 of the 1993 Alabama Legislature, the undersigned hereby adopt the following Limited Liability Company Articles or Organization:

**ARTICLE I
THE NAME OF THE LIMITED LIABILITY COMPANY IS:**

TSG Construction, L.L.C.

**ARTICLE II
DURATION**

The period of its duration is perpetual.

**ARTICLE III
PURPOSES**

The Limited Liability Company has been organized for the following purposes:

- (a) To engage in the transaction of any or all lawful business for which limited liability companies may be organized under the laws of the State of Alabama;
- (b) To acquire, own, maintain, develop, improve, sell, lease or otherwise dispose of real estate;
- (c) To borrow money and to evidence the same by notes or other evidences of indebtedness and to secure the same by mortgage, deed of trust, pledge or other lien or security interest in furtherance of any or all of the purposes of the Company;
- (d) To do any other acts and things which may be necessary, appropriate or incidental to the carrying out of the business and purposes of the company, subject to the terms and conditions of the Operating Agreement.

MANAGEMENT OF COMPANY

ARTICLE VII
ADDITIONAL MEMBERS

CONTINUATION OF BUSINESS

The members of the Company shall have the right to continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member of the Limited Liability Company if (i) there are at least two remaining members or at least one remaining member and a new member is admitted; and (ii) the legal existence and business of the Company is continued by a written consent of all the remaining members within 90 days after the occurrence of the evidence of dissolution.

ARTICLE IX
LIABILITY OF MEMBERS

As provided in the Alabama Limited Liability Company Act, the members of the Company shall have no liability for any debt, obligation or liability of the Company.
