KNOW ALL MEN BY THESE PRESENTS, That in consideration of **THREE HUNDRED THIRTY-SEVEN THOUSAND NINE HUNDRED DOLLARS AND NO/100's (\$337,900.00)** to the undersigned grantor, CROWN CONSTRUCTION CO., INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto **PAUL K. BROWN and KAREN S. BROWN** (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:
