- B. CONSTRUCTION/PERMANENT MORTGAGE RIDER

(FORM MD-1-AL)

This Construction/Permanent Mortgage Rider is made this 9th day of April, 1999, and is incorporated into and shall be deemed to amend and supplement the Mortgage of the same date given by the undersigned ("Borrower" or "Mortgagor") to secure Borrower's Note to First National Bank of Shelby County ("Lender") of the same date or subsequent renewal or refinancing, and covering the property described in the Mortgage.

ADDITIONAL COVENANTS. In addition to the covenants and agreements made in the Mortgage, Borrower and Lender further covenant and agree as follows:

- 1. Construction/Permanent Loan. This Mortgage secures a loan incurred to finance the construction of Improvements on the Property, including in some cases the acquisition cost of the Property and certain costs incurred in planning, architectural and engineering studies, zoning or rezoning, and similar expenses. It is understood and agreed that funds to be advanced are to be used in the construction of the Improvements on the Property in accordance with the terms of the Note, Construction Loan Agreement, and other loan documents, which documents are incorporated herein by reference to the same extent as if fully set forth herein and made a part of this Mortgage.
