LOHMAN**, an unmarried woman, and **BARBARA COX KOEHLER, TRUSTEE** of the **TESTAMENTARY TRUST U/W OF KARL LOHMAN** each having a 1/2 interest in subject property, (herein referred to as grantors, whether one or more) do grant, bargain, sell, and convey their respective 1/2 interest unto **JAMES D. SMITH** and **ALISA Y. SMITH** (herein referred to as GRANTEEES) as joint tenants, with right of survivorship, the following described real estate, situated in Shelby County, Alabama:




