

ARTICLES OF ORGANIZATION
AMENDMENT "A" DATED APRIL 12, 1999
OF
Home Services, L.L.C.

The undersigned, acting as organizer of Home Services, L.L.C. (L.L.C.), a limited liability company organized pursuant the Alabama Limited Liability Company Act, hereby adopt the following Articles of Organization for the LLC:

1. The name of the LLC is "Home Services, L.L.C."
2. (a) The complete address of the LLC's initial registered office in Alabama is:

4. The name and address of the Home Services, LLC members are: Jerome Alan Speegle, Cristen David Speegle, Bess M. Speegle, Chad Eric Speegle, and Jonathan Paul Speegle. The address for the members are: 204 Lenox Lane; Birmingham, Alabama 35242.
5. At the date and time of filing of this Amendment 1 of these Articles, there are five (5) members of the LLC.
6. The purpose of the LLC is to perform residential construction, professional engineering services, and any other type of services for which the members have professional experience.
7. The complete address of the LLC's Owner/Organizer/Managers office is:

8. Initial Contribution - The members initially shall contribute to the Company capital as described in Attachment "Listing of Capital Contributions".
9. The liability of the Members shall limited as provided under the laws of Alabama Limited Liability statutes. Members that are not Managers shall take no part whatever in the control, management, and direction of the company. Members can obligate the Company for materials. The LLC will be managed by the Owner/Organizer/Manager.
10. The duration of the LLC is 45 years.
11. This LLC shall not be dissolved and shall not be required to be wound up by reason of any event that terminates the continued membership of a member if there is at least one (1) remaining member and the existing and business of the LLC is continued by the consent of the manager.
12. The manager shall have the right to add additional members. Any member who is subsequently admitted as a member of the Company shall have all the rights and obligations of a member under the "Limited Liability Company Agreement."
13. A member may be expelled at any time by consent of the manager at the time of such expulsion, inclusive of the voting power of the member whose expulsion is sought.
14. The company shall be managed by one the Owner/Organizer/Manager. The initial manager of the Company shall be Jerome Alan Speegle. The powers of the manager include: the sale, development lease of other disposition of the Company's assets; the purchase and other acquisition of other assets of all kinds; and the borrowing of money; the prepayment, refinancing or extension of any loan affecting the Company's assets. The manager shall determine and distribute funds when he wants to.
15. This Amendment "A" replaces the initial Home Services L.L.C. document recorded on May 11, 1998.
