THIS MORTGAGE IS DATED APRIL 22, 1999, between Proctor & Sons Builders, Inc., whose address is P. O. Box 381074, Birmingham, AL 35238 (referred to below as "Grantor"); and Regions Bank, whose address is P. O. Box 10247, Birmingham, AL 35202 (referred to below as "Lender").

GRANT OF MORTGAGE.
