SUBORDINATION OF RECORDED FINANCING STATEMENT

Amsouth Bank, a state banking corporation, for good and valuable consideration, does hereby acknowledge and agree that its lien and security interest evidenced and secured by that certain UCC-X financing statement bearing file no. 1999-11988, showing Roger E. and Michelle J.
