The annual percentage rate on the date pf this 10.750 %. The annual percentage rate will increase if the Prime Rate in effect on the mortgage is first day of a billing cycle increases, and will decrease if the Prime Rate in effect on the first day of a billing cycle decreases; however, the annual percentage rate will never exceed the Maximum Rate stated in the Credit Agreement. Any increase in the annual percentage rate may result in increased finance charges and increased minimum payment amounts under the Credit Agreement. Any decrease in the annual percentage rate may result in lower finance charges and lower minimum monthly payments.

- C. Maturity Date. If not sooner terminated as set forth therein, the Credit Agreement will terminate twenty years from the day of the Credit Agreement, and all sums payable thereunder (including without limitation principal, interest, expenses and charges) shall become due and payable in full.
- D. Mortgage Tax. This mortgage secures open-end or revolving indebtedness with an interest in residential property. The Mortgagee is hereby authorized on behalf of, and in the name of, the Mortgager to execute and deliver valid assignments for, and appeal from, any such judgments or awards.
