MORTGAGE

Tenancy at Sufferance. Election by Lander to pursue any remedy shall not exclude pursuit of any other remedy, and an election to make expenditures or take action to perform an obligation of Grantor under this Mortgage after failure of Grantor to perform shall not affect Lender's right to declare a default and exercise its remedies

Attorneys' Fees; Expenses. If Lender institutes any suit or action to enforce any of the terms of this Mortgage, Lander shall be entitled to recover such sum as the court may edjudge reasonable as attorneys' fees at trial and on any appeal. Whether or not any court ection is involved, all reasonable expenses incurred by Lender that in Lender's opinion are necessary at any time for the protection of its interest or the enforcement of its rights shell become a part of the indebtedness payable on demand and shall bear interest from the date of expenditure until repeld at the rate provided for in the Credit Agreement. Expenses covered by this paragraph include, without limitation. however subject to any limits under applicable law, Lender's attorneys' fees and Lender's legal expenses whether or not there is a lawsuit. including attorneys' fees for bankruptcy proceedings (including efforts to modify or vacate any automatic stay or injunction), appeals and any anticipated post-judgment collection services, the cost of searching records, obtaining title reports (including foreclosure reports). surveyors' reports, and appraisal fees, and title insurance, to the extent permitted by applicable law. No prior weiver by Lender, nor any course of dealing between Lender and Grantor, shall constitute a waiver of any of Lender's rights or any of Grantor's obligations as to any future transactions. Whenever consent by Lander is required in this Mortgage, the granting of such consent by Lander in any instance shall not constitute continuing consent to subsequent instances where such consent is required.
