

SUBORDINATION AGREEMENT

STATE OF ALABAMA, Shelby COUNTY:

This Subordination Agreement, made and entered into on this the 15th day of October, 1998 ~~x-1998~~ by
and between

COMPASS BANK

as party of the First Part, and:

COMPASS BANK

as party of the Second Part

WITNESSETH:

THAT, WHEREAS, JOHN M. MAGEE, has an outstanding loan in favor of:
COMPASS BANK
dated the 26th day of June, 1998, 1998, and recorded in the Probate Office of Shelby County,
Alabama, on certain real estate described therein to secure an indebtedness of: 20,000.00, and said loan is in
full force and effect; and,

WHEREAS, JOHN M. MAGEE, has made an application to the Party of the Second Part for a loan in the sum of
\$130000.00 and said Party of the Second Part is willing to make said loan to the said JOHN M. MAGEE, provided
he/she/they furnish it with a mortgage on the lands described in the aforesaid loan, and the said Party of the First Part
subordinate the above-described loan and make the same second and subservient to the mortgage of COMPASS BANK,
and which mortgage is a rate reduction refinance with no cash to borrower.

WHEREAS, the said Party of the First Part is willing to subordinate its said loan and make the loan second and
subservient to the mortgage of the said Party of the Second Part as an inducement to it to make said loan.

NOW, THEREFORE, in consideration of the premises and the further consideration of the sum of
\$ 10.00, cash, in hand paid, the Party of the First Part by the Party of the Second Part, the receipt of
which is hereby acknowledged, the said Party of the First Part does hereby agree that the loan of JOHN M. MAGEE
dated 6-26-98, and recorded in Probate Office of Shelby County, Alabama in Volume 1998 at
Page 25179, to secure the said loan shall be subordinate to the mortgage of COMPASS BANK.

IT IS FURTHER agreed that should JOHN M. MAGEE default in the payments under the terms of the real estate
mortgage to Party of the Second Part, the said Lender agrees to notify Party of the First Part of said default prior to taking
legal action.
