TO HAVE AND TO HOLD such Property unto Mortgagee and to Mortgagee's successors and assigns, torever, together with all buildings and other improvements now or hereafter erected on the Property and all easements, appurtenances pand fixtures, now or hereafter a part of the Property, and all rights and interests which derive from our (Borrower/Borrowers) ownership, use or possession of the Property and all appurtenances thereto. All of the foregoing is referred to in this Mortgage as the "Property" or "premises".

OWNERSHIP: Borrower covenants that Borrower is the sole owner(s) of the Property and is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property to you (Mortgagee) and that the Property is unencumbered, except for encumbrances of record. You may also sign our name to any check, draft or other order for the payment of insurance proceeds in the event of loss or damage to the Premises, if you receive payment of a claim, you will have the right to choose to use the money either to repair the Premises or to reduce the amount owing on the Note.
- (c) CONDEMNATION: We assign to you the proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Premises, or part thereof, or for conveyance in heu of condemnation, all of which shall be paid to you, subject to the terms of any Prior Mortgage.
- (f) SECURITY INTEREST: We will join with you in signing and filing documents and, at our expense, in doing whatever you believe is necessary to perfect and continue the perfection of your lien and security interest in the Premises.
- (g) OUR AUTHORITY TO YOU: If we fail to perform our obligations under this Mortgage, you may, it you choose perform our obligations and pay such costs and expenses. As used in this paragraph, "Environmental Law" means federal laws and laws of the jurisdiction Where the Premises are located that relate to health, safety or environmental protection.

- (j) SALE OF PREMISES: We will not sell, transfer ownership of, mortgage or otherwise dispose of our interest in the Premises, in whole or in part, or permit any other hen or claim against the Premises without your prior written consent. If all or any part of the Premises or any interest in it is sold or transferred without Mortgagee's prior written consent. DEFAULT: Except as may be prohibited by applicable law, and subject to any advance notice and cure period it required by applicable law, if any event or condenon described in Paragraph 12.A. of the Note occurs, or we tail to perform any of the obligations and agreements assumed by us under the provisions of this Mortgage, you may foreclose upon this Mortgage pursuant to the provisions of the paragraph hereinafter set forth, entitled "Foreclosure by Power of Sale". This means that you may arrange too the Premises to be sold in the manner provided in the preceding sentence herein, in order to pay off what we owe on the Note and under this Mortgage. It the money you receive from the sale is not enough to pay off what we owe you, we will still owe you the difference which you may seek to collect from us in accordance with applicable law. In addition, you may in accordance with applicable law, (i) enter on and take possession of the Premises; (ii) collect the remal payments, including overdue rental payments, directly from tenants; (iii) manage the Premises; and (iv) sign, cancel and change leases.
