KNOW ALL MEN BY THESE PRESENTS: That I, Demerle Lawley Goggins, of Shelby County, Alabama, being of sound mind and disposing memory, and not acting under duress, menace, fraud or undue influence of any person or persons, do make and publish this and declare this to be my Last Will and Testament, hereby revoking any and all former Wills and Codicils by me heretofore made.
