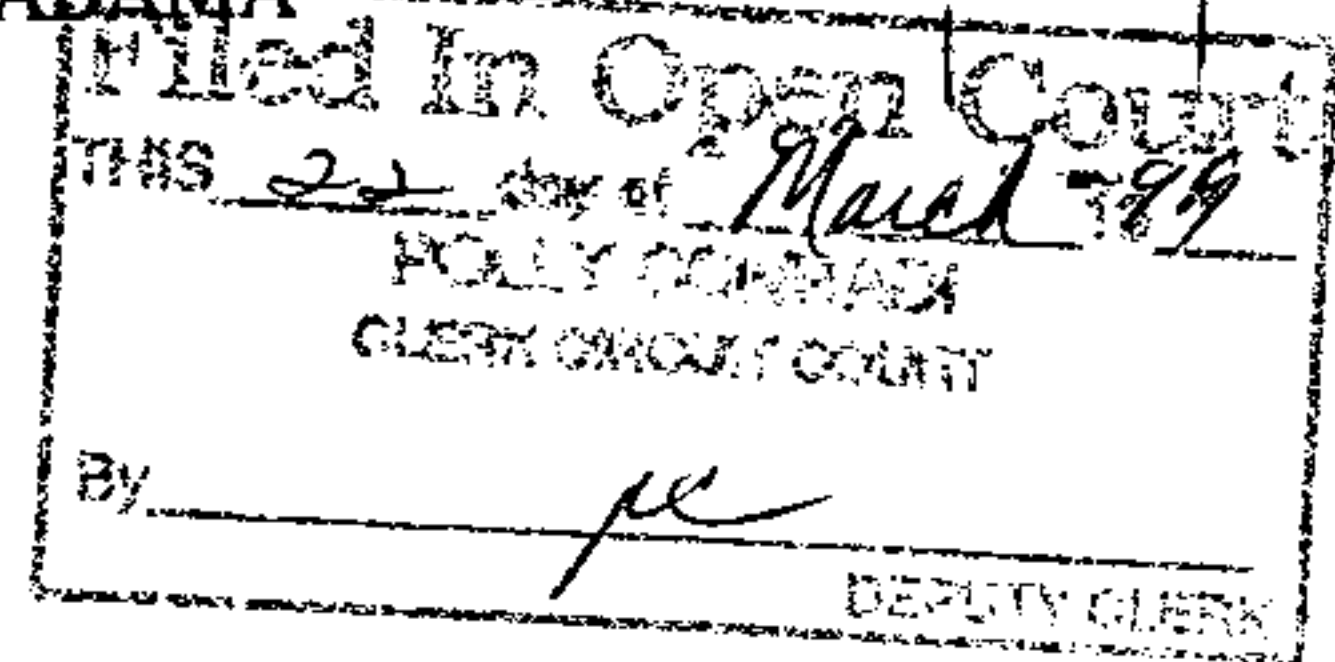

ORDER

In accordance with the Jury Verdicts, it is hereby ordered as follows:

Judgment is hereby rendered in favor of the counter-plaintiff Roger Graul and against the counter-defendants, S & R Travels, Inc.; H. Thomas Smith; and Cynthia S. Smith, in the amount of Eighty-Eight Thousand Dollars (\$88,000.00) in compensatory damages and One Hundred Thousand Dollars (\$100,000.00) in punitive damages, for a total judgment in favor of Roger Graul of One Hundred Eighty-Eight Thousand Dollars (\$188,000.00).

Judgment is hereby rendered in favor of the counter-plaintiff Diversified Business Consultants, Inc., and against the counter-defendants, S & R Travels, Inc.; H. Thomas Smith; and Cynthia S. Smith, in the amount of Seventy-Two Thousand Dollars (\$72,000.00) in compensatory damages and Forty Thousand Dollars (\$40,000.00) in punitive damages, for a total judgment in favor of Diversified Business Consultants, Inc., of One Hundred Twelve Thousand Dollars (\$112,000.00).

Costs of court incurred are taxed against the counter-defendants, S & R Travels, Inc.; H. Thomas Smith; and Cynthia S. Smith.
