MORTGAGE

THIS MORTGAGE IS DATED APRIL 30, 1999, between JOE MOYNIHAN and DAWN B. GRANT OF MORTGAGE. Rents. The word "Rents" means all present and future rents, revenues, income, issues, royalties, profits, and other benefits derived from the Property.

Application of Net Proceeds. If all or any part of the Property is condemned by eminent domain proceedings or by any proceeding or purchase in lieu of condemnation, Lender may at its election require that all or any portion of the net proceeds of the award be applied to the Indebtedness or the repair or restoration of the Property. Proceedings.
