AMENDMENT TO MORTGAGE ASSIGNMENT

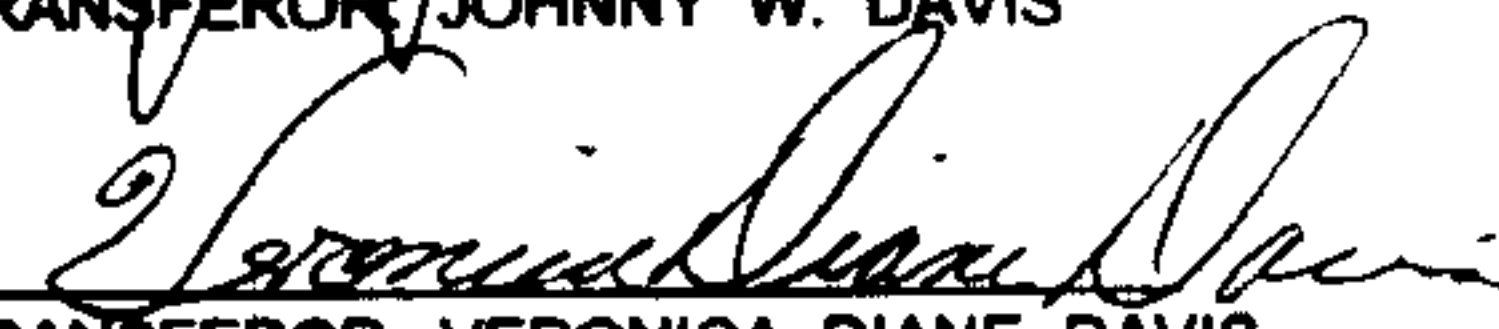
