KNOW ALL MEN BY THESE PRESENTS, That the undersigned Colonial Pipeline Company, a Delaware Corporation, for and in consideration of the sum of One and No/100 Dollars (\$1.00) to it in hand paid by Alabama Power Company, a corporation, the receipt whereof is hereby acknowledged, does hereby grant to said Alabama Power Company, its successors and assigns, the right to cut and trim and to keep cut and trimmed, and remove any timber or other woody growth, including overhanging limbs, for a distance of 15 feet onto Grantor's property adjacent to public road right of way on which the electric transmission lines of Grantee are to be constructed, and the right to install guy wires and anchors on Grantor's property both within and beyond such 15 feet, and the right cut and trim and to keep cut and trimmed and remove any timber (referred to as danger trees) located beyond the above-mentioned 15 feet onto Grantor's property which in falling would come within five (5) feet of the electric transmission lines of Grantee to be constructed on public road right of way adjacent to Grantor's land. Such lands and rights are situated in:

Southeast Quarter of the Northwest Quarter (SE ¼ of NW ¼) and the Southwest Quarter of the Northeast Quarter (SW ¼ of NE ¼) of Section 24, Township 20 South, Range 3 West, Shelby County, Alabama.

The approximate center line of construction of such electric transmission lines is described as follows:

To reach the point of beginning of the center line of construction, commence at the Southwest corner of Section 24, Township 20 South, Range 3 West; thence run North along the West boundary line of said Section 24 a distance of 2788.70 feet to a point; thence turn a deflection angle to the right of 93 degrees 00 minutes and run South 88 degrees 24 minutes East a distance of 579.8 feet to a point; thence turn a deflection angle to the left of 28 degrees 05 minutes and run North 65 degrees 31 minutes East a distance of 1565.45 feet to a point, such point being the point of beginning of said approximate center line of construction and the continuations thereof which begins at such point of beginning and turns a deflection angle to the right of 43 degrees 23 minutes 38 seconds and runs South 71 degrees 05 minutes 24 seconds East a distance of 1082 feet, more or less, to a point, such point being the point of ending.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever.
