KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Seventy-Seven Thousand Nine Hundred and no/100 Dollars (\$177,900.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **UNITED HOMEBUILDERS, INC.**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **CHARLES E. McCARY, JR. & RHONDA W. McCARY**, (herin referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 10, according to the Survey of Oak Park, Sector 2, Phase 1, as recorded in Map Book 24, page 120, in the Probate Office of Shelby County, Alabama.
