## MORTGAGE MODIFICATION AGREEMENT

This modification agreement, made this 17th day of May, 1999, by and between North Shelby County Library District, ("Borrower") and BANCORPSOUTH BANK ("Lender").

## **RECITALS**

- A. On June 4, 1998, Borrower executed and delivered to Lender a mortgage ("the mortgage") covering the property described in Exhibit A (said mortgage being recorded in the Office of the Judge of Probate of Shelby County, Alabama in Instrument #1998/20901 as security for a loan by Lender to Borrower in the original principal sum of \$2,400,000.00.
- B. Borrower has requested and Lender has agreed to increase the amount in the manner set forth herein.

## **AGREEMENTS**

NOW, THEREFORE, in consideration of the recitals and to induce the Lender to increase the amount of the Note and Mortgage, the parties agree as follows:

- 1. The amount of the mortgage is increased from the original principal sum of \$2,400,000.00 to the principal sum of \$2,900,000.00.
- 2. The term "Note" or "Promissory Note" as referred in the Mortgage shall refer to such instrument being duly executed on, June 4, 1998, and as the same may hereafter be amended, extended, renewed, modified or changed.
- 3. Except as herein amended, the Mortgage shall remain in full force and effect, and the Mortgage, as herein amended, is hereby ratified and affirmed in all respects. Borrower confirms that they have no defenses or offsets with respect to Borrowers' obligations pursuant to the Note or the Mortgage as herein amended.
