KNOW ALL MEN BY THESE PRESENTS, That in consideration of ONE HUNDRED SEVENTY-EIGHT THOUSAND FIVE HUNDRED AND 00/100 DOLLARS (\$178,500.00) to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, I/we HAL L. CURTIS and wife, GAYLE F. CURTIS, (herein referred to as grantors, whether one or more) do grant, bargain, sell, and convey unto RONALD E. AKINS and JUDITH L.
