MORTGAGE

THIS MORTGAGE IS DATED MAY 19, 1998, between JAMES M. PETRUZELLA and DENIA A. PETRUZELLA, HUSBAND AND WIFE, whose address is 7072 BRADISTOCK CT, BIRMINGHAM, AL 35242 (referred to below as "Grantor"); and AmSouth Bank, whose address is 102 Inverness Plaza, Birmingham, AL 35243 (referred to below as "Lender").

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, grants, berguins, sells and conveys to Lender all of Grantor's right title, and interest in and to the following described real property, together with all existing or subsequently erected or affixed buildings improvements and fixtures; all essements, rights of way, and appurtenences; all water, water rights, watercourses and ditch rights (including stock in utilities with ditch or irrigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar matters, located in SHELBY County, State of Alabama (the "Real Property"):

Granter presently assigns to Lender all of Granter's right, title, and interest in and to all leases of the Property and all Rents from the Property in addition, Granter grants to Lender a Uniform Commercial Code security interest in the Personal Property and Rents

DEFINITIONS. The following words shall have the following meanings when used in this Mortgage. Terms not otherwise defined in this Mortgage shall have the meanings attributed to such terms in the Uniform Commercial Code. improvements. The word "Improvements" means and includes without limitation all existing and future improvements, buildings structures, mobile homes affixed on the Real Property, facilities, additions, replacements and other construction on the Real Property

indebtedness. The word "Indebtedness" masns all principal and interest payable under the Credit Agreement and any amounts expended or advanced by Lender to discharge obligations of Grantor under this Mortgage together with interest on such amounts as provided in this Mortgage and any and all other present or future, direct or contingent Mortgage together with interest on such amounts as provided in this Mortgage and any and all other present or future, direct or contingent Mortgage together with interest on such secured or unsecured, except that the word "indebtedness" shall not include any debt subject to the disclosure requirements of the Federal secured or unsecured, except that the word "indebtedness" shall not include any debt subject to the disclosure requirements of the Federal Truth-in-Landing Act if, at the time such debt is incurred, any legally required disclosure of the lien afforded hereby with respect to such debt shall not have been made. Personal Property. The words "Personal Property" mean all equipment, fixtures, and other articles of personal property now or hereafter owned by Grantor, and now or hereafter attached or affixed to the Real Property; together with all accessions, parts, and additions to, all replacements of, and all substitutions for, any of such property; and together with all proceeds (including without limitation all insurance proceeds and refunds of premiums) from any sele or other disposition of the Property.

Property. The word "Property" means collectively the Real Property and the Personal Property.

Related Documents. Right To Contest. Whether or not Lender's security is impaired, Lander may, at its election. apply the proceeds to the reduction of the indebtedness, payment of any lien affecting the Property, or the restoration and repair of the Property. Defence of Title. Subject to the exception in the paragraph above, Grantor warrants and will forever defend the title to the Property equinst the lawful claims of all persons. Application of Net Proceeds. FULL PERFORMANCE. If Grantor pays all the Indebtedness, including without limitation all advances secured by this Mortgage, when due terminates the credit line account by notifying Lender as provided in the Credit Agreement, and otherwise performs all the obligations imposed upon Grantor under this Mortgage. Election by Lendar to pursue any remedy shall not exclude pursuit of any other remedy, and an election to make expenditures or take action to perform an obligation of Grantor under this Mortgage after failure of Grantor to perform shall not affect Lendar's right to declare a default and exercise its remedies under this Mortgage.

Attorneys' Fees; Expenses. Expenses covered by this paragraph include, without similation however subject to any limits under applicable law.
