KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Hundred Fourteen Thousand Nine Hundred and 00/100 (\$114,900.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, John E. Taylor and wife, Sonja Taylor (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, David Thomas Rampey and Angela M. Rampey, husband and wife, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 70, according to the Survey of Brookhollow, First Sector, as recorded in Map Book 17, page 103, in the Probate Office of Shelby County, Alabama. Mineral and mining rights excepted.



Subject to existing easements, current taxes, restrictions, set-back lines and rights of way, if any, of record.
