This Construction Mortgage Rider is made this 14th day of June, 1999, and is incorporated into and shall be deemed to amend and supplement the Mortgage of the same date given by the undersigned ("Borrower" or "Mortgagor") to secure Borrower's Note to First National Bank of Shelby County ("Lender") of the same date and covering the property described in the Mortgage.

addition to or in substitution for the covenants and agreements made in the Mortgage, Borrower and Lender further covenant and agree as follows:

- Mortgage shall also include all personal property specifically described in the Mortgage and all building permits, contracts, agreements, plans, specifications, surveys, engineering reports, materials, equipment, fixtures, tools, apparatus and fittings of every kind or character now owned or hereafter acquired by Borrower for the purpose of, or used or useful in connection with, the construction of the Improvements, wherever the same may be located.
- 2. Construction Loan. This Mortgage secures a loan incurred to finance the construction of Improvements on the Property, including in some cases the acquisition cost of the Property and certain costs incurred in planning, architectural and engineering studies, zoning or rezoning, and similar expenses.
