**WARRANTY DEED**

KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Eighty-Five Thousand and no/100 Dollars ( \$ 185,000.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, UNITED HOMEBUILDERS, INC., (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto KEVIN M. DAVIS & DEBRA R. DAVIS, (herin referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 16A, according to the Survey of Oak Park, Sector 2, Phase 1, as recorded in Map Book 24, page 120, in the Probate Office of Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way and covenants of record; taxes for 1999 and subsequent years not yet due and payable.

AND THE GRANTOR does for itself, successors and assigns, covenant with said Grantee, their heirs, executors, successors and assigns, that Grantor is lawfully seized in fee simple of the premises, that they are free from all encumbrances, unless otherwise noted above, that Grantor has good right to sell and convey the same as aforesaid, and that Grantor will and its successors and assigns shall warrant and defend same to said Grantee, their heirs, executors, successors and assigns forever, against the lawful claims of all persons.
