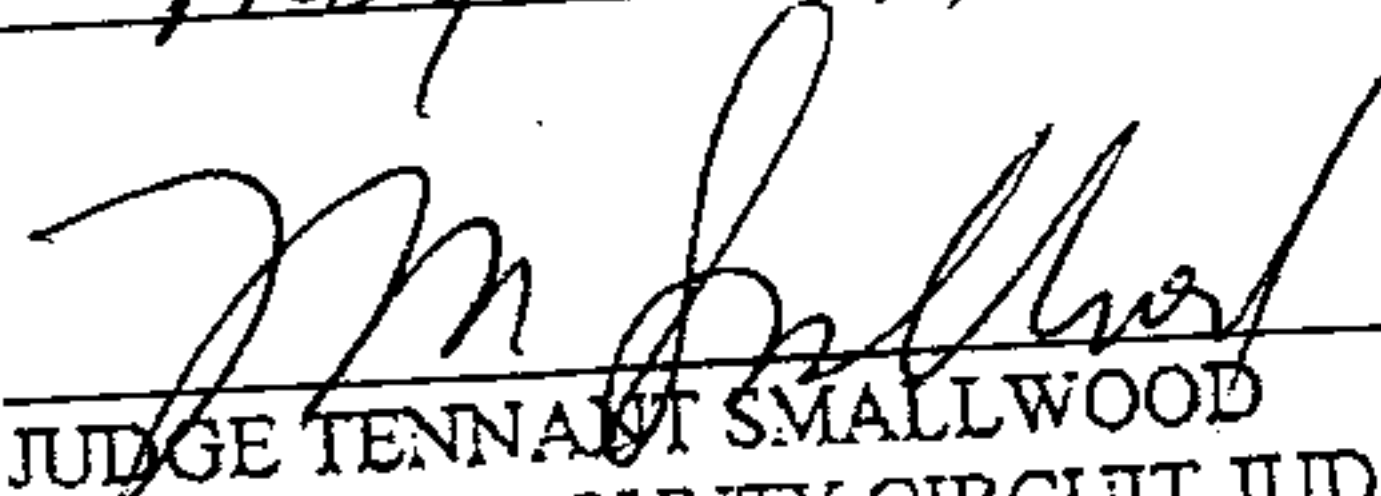

That judgment is rendered in favor of Koger and against Outfitters and McKenzie, jointly and severally, in the amount of \$17,998.30 plus court costs.

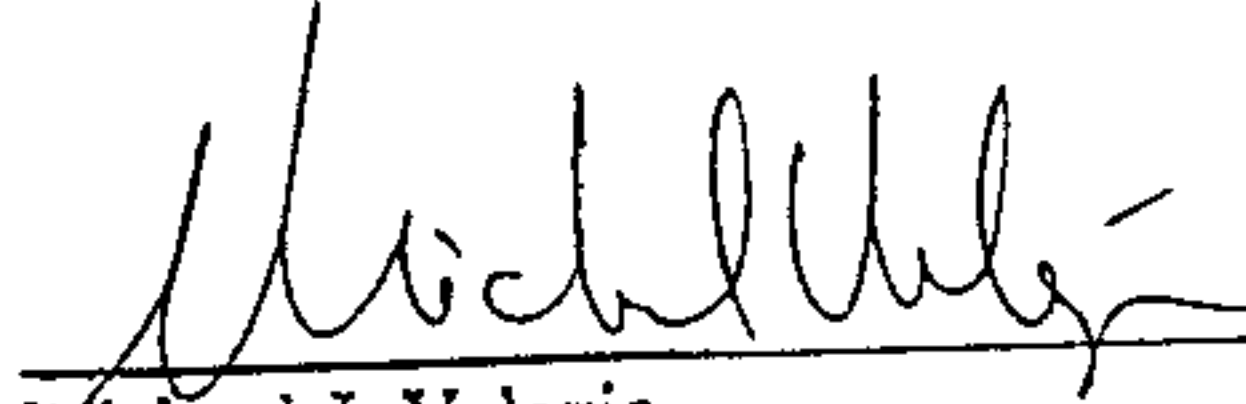
That judgment is rendered in favor of Koger and against Toffel in the amount of \$1,000.

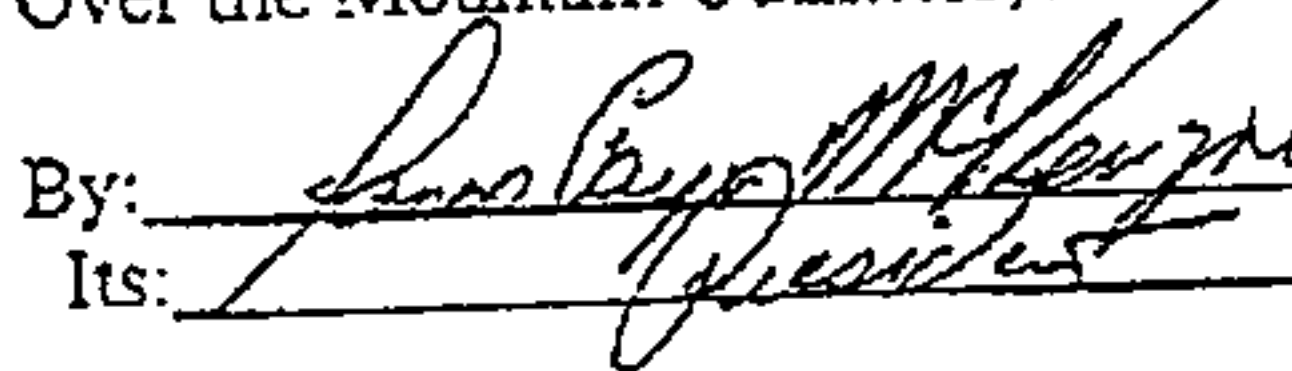

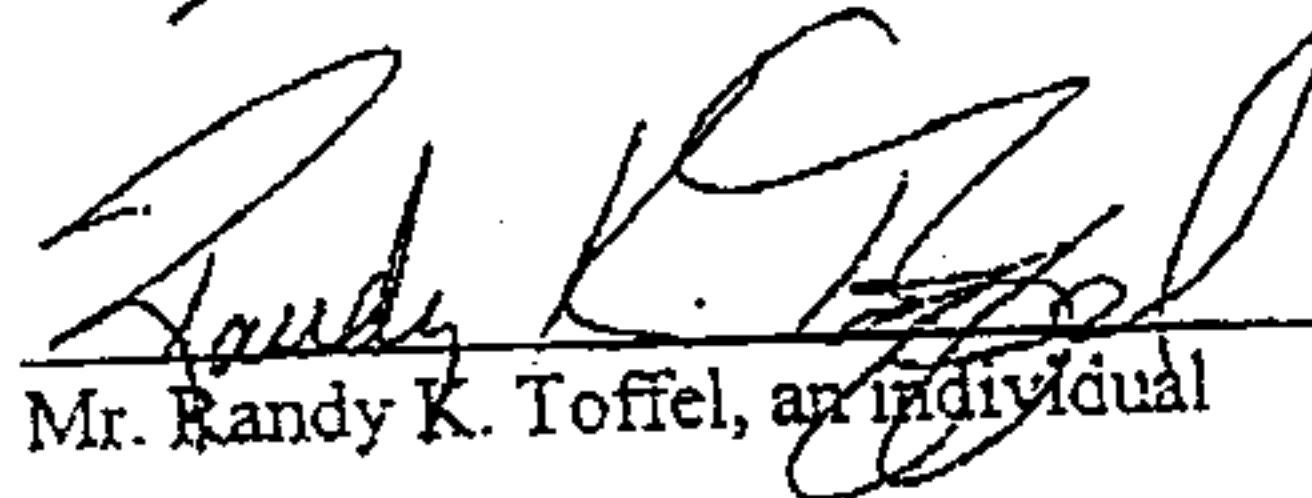
