KNOW ALL MEN BY THESE PRESENTS, That in consideration of **TWO HUNDRED NINETY-SIX THOUSAND NINE HUNDRED DOLLARS AND NO/100's (\$296,900.00)** to the undersigned grantor, **M.A. FRAZIER CONSTRUCTION, INC.**, a corporation, (herein referred to as **GRANTOR**), in hand paid by the **GRANTEES** herein, the receipt of whereof is acknowledged, the said **GRANTOR** does by these presents grant, bargain, sell, and convey unto **EDWARD RAYMOND TAYLOR and MELINDA NORTON TAYLOR** (herein referred to as **GRANTEES**) as joint tenants, with right of survivorship, the following described real estate, situated in **SHELBY County, Alabama**:
