- (i) All rents, royalties, profits, issues and revenues of the Land and improvements from time to time accruing, whether under leases or tenencies now existing or hereafter created; and
- All judgments, awards of damages and actionents hereafter made resulting from condemnation proceedings or the taking of the Land and improvements or any part thereof under the power of eminent domain, or for any damage (whether caused by such taking or otherwise) to the Land and improvements or any part thereof, or to any rights appurtanent thereof, including any award for change of grade or streets. Lender is hereby authorized on behalf of and in the name of Borrowier to execute and deliver valid acquittances for, and appeal from, any such judgments or awards. Lender may apply all such sums or any part thereof so received, after the payment of all its expanses, including soots and accordings' fees, on any of the indebtedness secured hereby in such manner as it elects or, at its option, the entire amount or any part thereof so received may be released;
- All cash and non-each proceeds and all products of any of the foregoing Items or types of property described in (a), (b), (c) or (d) above, including, but not limited to, all insurance, contract and tort proceeds and claims, and including all inventory, accounts, chattel paper, documents, instruments, equipment, fixtures, consumer goods and general intengibles acquired with each proceeds of any of the foregoing items or types of property described in (a), (b), (c) or (d) above.

TO HAVE AND TO HOLD the Mortgeged Property and all parts thereof unto the Lender, its successors and essigns forever, subject, however, to the terms and conditions herein;

PROVIDED, HOWEVER, that these presents are upon the condition that, (i) if the Borrower shall fully pay or cause to be fully paid to the Landar the principal and interest payable with respect of the Loan and the Note, and any extensions, renewals, modifications and refinancings of same, at the times and in the manner stipulated therein and herein, all without any deduction or credit for taxes or other similar charges paid by the Borrower, and shall pay all charges incurred herein by Lander on account of Sorrower, including, but not limited to, attorneys' less, and shall pay any and all Other Indebtedness, and shall keep, perform and observe all and singular the covenants, conditions and agreements in this pay any and all Other Indebtedness, and shall keep, perform and observe all and singular the covenants, conditions and agreements in this Mortgage, in the Note, in the other Loan Documents, and in the Other indebtedness instruments expressed to be kept, performed, and observed by or on the part of the Borrower, all without fraud or dalay, and (ii) the Lender shall have no further commitment or agreement to make advances, incur obligations or your relating to future advances, openiend, revolving or other lines of oradit), then this Mortgage, and all the properties, interest and rights hereby granted, bargained, sold and conveyed shall cease, terminate and be void, but shall otherwise remain in full force and effect.

AND the Borrower further represents, warrants, covenants and agrees with the Lander as follows:

#### ARTICLE I GENERAL

- 1.03 Performance of Martgage, Note and Loan Documents. The Borrower shall perform, observe and comply with all provisions hereof, of the Note, of the Loan Documents, and of the Other Indebtedness Instruments, and shall duly and punctually pay to the Londer the sum of money expressed in the Note, with Interest thereon, and all other sums required to be paid by the Borrower pursuant to the provisions of this Mortgage, of the Note, of the other Loan Documents, and of the Other Indebtedness Instruments, all without any deductions or credit for taxes for other similar charges paid by the Borrower.
- 1.02 Warranty of Title. Borrower heraby warrants that it is lewfully seized of an indefeasible estate in fee simple in the land and resignoperty hereby mortgaged, or is lawfully seized of such other estate or interest as is described on Exhibit A hereto, and has good and absolute tutis to all existing personal property hereby granted as security, and has good right, full power and lewful authority to sell, convey, mortgage and grant a security interest in the same in the manner and form aforessid; that the same is free and clear of all grants, reservations, security interests, there can denoumbranese whatseever, including, as to the personal property and fixtures, conditional sales contracts, interests, lions, charges, and encumbranese whatseever, including, as to the personal property and fixtures, conditional sales contracts, mortgages, security agreements, financing statements, and anything of a similar nature, and that Borrower shall and will warrant and forever defend the title thereto and the quiet use and enjoyment thereof unto the Lender, its successors and assigns, against the lawful claims of all parsons whomsoever.
- 1.03 Future Advances, Revelving and Open-lind Loans, and Other Debts. It is expressly understood that this Mortgage is intended to and does secure not only the Loan, but also future advances and any and all Other Indebtedness, obligations and Sabilities, direct or contingent, of the Borrower to the Lender, whether now existing or hereafter arising, and any and all extensions, renewals, modifications and refinancings of same, or any part thereof, existing at any time before actual concellation of this instrument on the probate records of the sounty or counties where the Mortgaged Property is located, and whether the same be evidenced by note, open account, assignment, endorsement, guaranty, pladge or otherwise. The Loan and the Other Indebtedness may, if provided in the applicable loan instruments, provide for revolving or open-and loans and advances, all of which shall be secured by this Mortgage.
- 1.04 Monthly Tax Deposit. If required by Lander, Borrower shall pay on the first day of each month one-twelfth (1/12) of the yearly taxes on the Mortgaged Property, as estimated by Lander, in addition to each regular installment of principal and interest. Such sums shall not draw interest and shall not be, nor be deemed to be, trust funds, but may be commingled with the general funds of Lender. Borrower agrees to pay Lander the amount of any deficiency necessary to enable Lender to pay such taxes when due. Such sums may be applied by the Lender to the reduction of the indebtedness secured hereby in any menner selected by Lender if on Event of Default shall occur under this Mortgage or under the Note, any of the other Loan Documents, or any of the Other Indebtedness Instruments, but, unless otherwise agreed by the Lander in writing, no application of tax deposits to the Note, to Other Indebtedness, or to other obligations secured hereby, shall delay, reduce, after or otherwise affect any regularly scheduled payment with respect to the Loan, the Other Indebtedness, or any such other obligations.

#### 1.05 Other Taxes, Utilities and Liens.

- The Borrower shall pay promptly, when and as due, end, if requested, will exhibit promptly to the Lender receipts for the payment of all taxes, assessments, water rates, utility charges, dues, charges, fines, penalties, costs and other expenses incurred, and impositions of every nature whatevers imposed, levied or assessed upon or against the Mertgaged Property or any part thereof or upon the revenues, rents, issues and profits of the Mertgaged Property or arieing in respect of the occupancy, use or possession thereof, or upon the interest of the Lender in the Mortgaged Property (either than any of the same for which provision has been made in Paragraph 1.04 of this Article I), or any charge which, if unpaid, would become a lien or charge upon the Mortgaged Property.
- (b) The Borrower premptly shall pay and shall not suffer any mechanic's, laborer's, statutory or other lien to be created or to remain outstanding upon any of the Mortgeged Property.
- In the event of the passage of any state, federal, municipal or other governmental law, order, rule or regulation, subsequent to the date hereof, in any menner changing or modifying the laws now in force governing the texation of mortgages or the menner or collecting texas, then Borrower immediately shall pay any increased texas if allowed by law, and if Borrower falls to say such additional texas, or if Borrower is prohibited from paying such texas, or if Lander in any way is adversally affected by such law, order, rule or regulation, then in any of such events, all indebtedness accured by this Mortgage and all interest accrued thereon shall without notice become due and payable forthwith at the option of the Lander.

#### 1.06 Insurance.

(a) The Sorrower shall produce for, deliver to, and maintain for the benefit of the Lender during the term of this Mortgage insurance policies in such amounts as the Lender shall require, insuring the Mortgaged Property against fire, extended goverage, was damage 0f available), and such other insurable hazards, assualties and centingenoiss as the Lender may require. The form of such policies and the companies issuing them shall be acceptable to the Lender, and, unless otherwise agreed by the Lender in writing, shall provide for goverage without coincurance or deductibles. All policies shall contain a New York standard, non-contributory mortgage endorsement making losses payable to the Lender, as mortgages. At least fifteen (15) days prior to the expiration date of all such policies, renewals thereof satisfactory to the Lender shall be delivered to the Lender. The Borrower shall deliver to the Lender receipts evidencing the payment of all such insurance policies and renewals. In the event of the foreclosure of this Mortgage or any transfer of title to the Mortgaged Property in partial or full extinguishment of the indebtedness secured hereby, all right, title and interest of the Borrower, or its assigns, in and to all insurance policies then in force shall pass to the purchaser or grantes.

- The Lender is hereby authorized and empowered, at its option, to adjust or compromise any lose under any insurance policies on the Mersgaged Property, and to epitiest and receive the proceeds from any such policy or policies. Seek insurance company hereby is authorized and directed to make payment for all such losses directly to the Lander instead of to the Borrower and Lander jointly. After deducting from said inducence precised any expenses incurred by Lender in the collection or handling of said funds, the Lander may apply the net proceeds, at its epition, sinher taward repairing or rectaring the improvements on the Mortgaged Property, or as a credit on any portion of the Sorrower's indebtedness adjected by Lander, whether then metured or to insture in the future, or at the option of the Lander, such sums either wholly or in part may be well to topple guan improvements, or to build now improvements in their place or for any other purpose and in a manner sedelectory to the Lander, all without affecting the lien of this Mortgage for the full amount secured hereby before such payment took place. Lander shall not De Bable to Bonewar or esterwise responsible for any failure to calledt any insurance proceeds due under the terms of any policy regardless of the cause of such fellure.
- If required by the Lander, the Berrawer shall pay on the first day of each month, in addition to any regular installment of principal and interest and other charges with respect to indebtedness secured hereby, and the monthly tex deposit provided for in Paregraph 1.04 hereof. one-twelfth (1/12) of the yearly premiums for insurance meletalned pursuant to the provisions of this Paragraph 1.06. Such amount shall be used by Lander to pay such insurance premiums when due. Buch edded payments shall not be, nor be deemed to be, trust funds, but may be commingled with the general funds of the Lender, and no interest shall be payable in respect thereof. Upon demand of the Lender, the Sorrower agrees to deliver to the Lender such additional moneys as are necessary to make up any deficiencies in the amounts deposited by Borrower with Lender pursuant to this Paragraph 1.06 to enable the Lender to pay such insurance premiums when due. In the event of an Event of Default hereunder or of a default by Berrower under the Note, any other Loen Documents, or any Other Indebtedness Instruments, the Lender may apply such sums to the reduction of the indebtedness secured hereby in any manner selected by Lender, but, unless otherwise agreed by the Lender in writing, no application of insurance proceeds to the Loan, to Other Indebtedness, or to other obligations secured hereby, shall delay, reduce, alter or otherwise affect any regularly scheduled payment with respect to the Loan, the Other Indebtedness, or any such other obligations.
- 1.07 Condemnation. If all or any part of the Mortgaged Property shall be damaged or taken through condemnation (which term when used in this Mortgage shall include any damage or taking by any governmental or private authority, and any transfer by private sale in lieu thereof). enther temporarily of permanently, the entire indebtedness sepured hereby shall at the option of the Lander become immediately due and payable. The Landar shall be entitled to all compensation, awards, and other payments or relief for any condemnation and is hereby authorized, at its option, to commence, appear in and prossoute, in its ewn or the Borrower's name, any action or proceeding relating to any condemnation, and to sattle or compromise any claim in connection therewith. All such compensation, awards, damages, claims, rights of action and proceeds and the right thereto are hereby sesigned by the Borrower to the Lender, which, after deducting therefrom all its expenses, including attorneys' less, may release any moneys so received by it without affecting the lien of this Mortgage or may apply the same in such manner as the Lender shall determine to the reduction of the indebtedness secured hereby, and any balance of such moneys then remaining shall be paid to the Borrower. The Barrower agrees to execute such further sesignments of any compensations, awards, damages, claims, rights of sation and proceeds as the Lander may require. The Borrewer shell promptly notify the Lender in the event of the institution of any condemnation or eminent domain proceeding or in the event of any threat thereof. The Lander shall be entitled to retain, at the expense of the Berrawer, its own legal counsel in connection with any such proceedings or threstened proceedings. Lender shall be under no obligation to the Borrower or to any other person to determine the sufficiency or legality of any condemnation award and may accept any such award without question or further inquiry.

#### 1.08 Care of the Property.

- (a) The Borrower will preserve and maintain the Mortgaged Property in good condition and repair, and shall not commit or suffer any waste and will not do or suffer to be done anything which will increase the risk of fire or other hazard to the Mortgaged Property or any part thereof.
- (b) Except as otherwise provided herein, no buildings, fixtures, personal property, or other part of the Mortgaged Property shall be removed, demolished or substantially altered without the prior written consent of the Lander. The Borrower may sell or otherwise dispose of, free from the lien of this Mortgage, furniture, furnishings, equipment, tools, appliances, machinery or appurtanences, subject to the lien hereof which may become worn out, undesirable, obsolete, disused or unnecessary for use in the operation of the Mortgaged Property, not exceeding in value at the time of disposition thereof Five Thousand Dollare (\$5,000.00) for any single transaction, or a total of Twenty Thousand Dollare (\$20,000.00) In any one year, upon replacing the same with, or substituting for the same, free and clear of all liens and security interests except those created by the Loan Documents or Other Indebtednese Instruments, other furniture, furnishings, equipment, tools, appliances, machinery or appurenences not necessarily of the same character, but of at least equal value and of equal or greater utility in the operation of the Mortgaged Property, and coating not less than the amount realized from the property sold or otherwise disposed of. Such substitute furniture, furnishings, equipment, tools, appliances, machinery and appurtenences shall forthwith become, without further action, subject to the provisions of this Mortgage.
- (c) If the Mortgaged Property or any part thereof is damaged by fire or any other cause, the Borrower shall give immediate written
- nouse of the same to the Lander. (d) The Lender is hereby authorized to enter upon and inspect the Mortgaged Property, and to inspect the Borrower's or Borrower's agent's records with respect to the ownership, use, management and operation of the Mortgaged Property, at any time during normal business
- (a) If all or any part of the Mortgaged Property shall be demoged by fire or other casualty, the Borrower shall promptly restore the hours. Mortgaged Property to the equivalent of its original condition, regardless of whether or not there shall be any insurance proceeds therefor; provided, however, that if there are insurance proceeds, the Borrower shall not be required to restore the Mortgaged Property as aforesaid unless the Lander shall apply any net proceeds from the security in question and held by Lender, as allowed under Paragraph 1.06, toward restoring the damaged improvements. If a part of the Mertgaged Property shall be physically damaged through condemnation, the Borrower promptly shall restore, repair or after the remaining property in a manner satisfactory to the Lender; provided, however, that if there are condemnation proceeds or awards, the Borrower shall not be required to restore the Mortgaged Property as aforesaid unless the Lender shall apply any net proceeds or awards from the condemnation and held by Lender, as provided in Paragraph 1.07, toward restoring the damaged improvements.

#### 1.09 Further Assurances; After-Acquired Property.

- (a) At any time, and from time to time, upon request by the Lender, the Borrower, at Borrower's expense, will make, execute and deliver or cause to be made, executed and delivered to the Lander and, where appropriate, to cause to be recorded and/or filed and from time to time thereafter to be re-recorded and/or refiled at such time and in such offices and places as shall be desirable by the Lender, any and all such other and further mortgages, instruments of further assurance, certificates and other documents as may, in the opinion of the Lander, be necessary or desirable in order to affectuate, complete, or perfect, or to continue and preserve the obligation of the Borrower under the Note and this Mortgage, and the priority of this Mortgage as a first and prior lien upon all of the Mortgaged Property, whether now owned or hereafter acquired by the Borrower. Upon any failure by the Borrower so to do, the Lender may make, execute, and record any and all such mortgages, instruments, certificates, and decuments for end in the name of the Borrower and the Borrower hereby knevocably appoints the Lander the agent and attorney-in-fact of the Borrower so to do. The Ben and rights hereunder automatically will attach, without further set, to all after-sequired property (except consumer goods, other than accessions, not acquired within ten (10) days after the Lender has given value under the Note) attached to and/or used in the operation of the Mortgaged Property or any part thereof.
- (b) Without limitation to the generality of the other provisions of this Mortgage, including subparagraph (a) of this Paragraph 1.09, it hereby expressly is governmented, agreed and acknowledged that the lien and rights hereunder autometically will attach to any further, greater, additional, or different estate, rights, titles or interests in er to any of the Mortgage Property at any time acquired by the Sorrower by whatevever means, including that in the event that the Borrower is the owner of an estate or interest in the Mortgaged Property or any part thereof (such es. for example, as the lesses or tenent) other than as the fee simple owner thereof, and prior to the satisfaction of record of this Mortgage the Borrower obtains or otherwise soquires such fee simple or other setate, then such further, greater, additional, or different estate in the Mortgaged Property, or a part thereof, shall automatically, and without any further action or flling or recording on the part of the Borrower or the Lender or any other person or entity, be and become subject to this Mortgage and the Non hereof. In consideration of Lender's making the Leon or aforesaid, and to secure the Loan, the Other Indebtedness and obligations set forth above, Borrower hereby grants, bargains, sells and conveys to Lander, on the same terms as set forth in this Mortgage and intended to be a part hereof, all such after-ecquired property and estates.
- 1.10 Additional Security. - [c] The filling by the Borrower or any guaranter of any indebtedness secured hereby or of any of Borrower's obligations hereunder, of a voluntary patition in bankruptcy or the Borrower's or any such guaranter's edjudication as a bankrupt or insolvent, or the filing by the Borrower or any such guaranter of any petition or answer seeking or acquiescing in any reorganization, arrangement, composition, readjustment, figuration, dissolution or similar relief for itself under any present or future federal, state or other statute, law or regulation relating to bankruptcy, insolvency or other relief for debtors, or the Borrower's or any such guaranter's seeking or consenting to or acquiescence in the appointment of any trustee, receiver or liquidator of the Borrower or any such guaranter or of all or any substantial part of the Mortgaged Property or of any or all or the rents, revenues, issues, earnings, profits or income thereof, or of any interest or estate therein, or the making of any general essignment for the benefit of creditors or the admission in writing of its inability to pay its debts generally as they become due; or
