MORTGAGE

THIS MORTGAGE IS DATED JULY 1, 1999, between FRANK L. BLANTON and KARLA S. GRANT OF MORTGAGE. DEFINITIONS. The following words shall have the following meanings when used in this Mortgage. Indebtedness.
