provided that no bond or undertaking or contract of suretyship executed under this authority shall exceed in amount the sum of Two Hundred Thousand (\$200,000) Dollars.



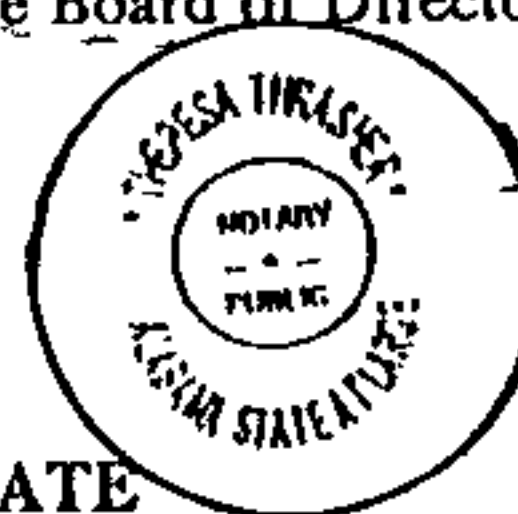
