Subordination Agreement

THIS AGREEMENT is made and entered into on this 25 day of June1999, by AmSouth Bank (hereinafter referred to as "AmSouth") in favor of Norwest Mortgage, Inc., its successors and assigns (hereinafter referred to as "Lender").

RECITALS

AmSouth loaned to Gail B. Logan & Williams S. Logan (the "Borrower", whether one or more) the sum of \$10,000. Such loan is evidenced by a note dated 10-12-95, executed by Borrower in favor of AmSouth, which note is secured by a mortgage, deed of trust, security deed, deed to secure debt, or other security agreement dated 10-30-95, and recorded in Mortgage Book 1995 at Page31131, in the public records of Shelby County, Alabama (the "AmSouth Mortgage"). Borrower has requested that Lender lend to it the sum of \$67,550, which loan will be evidenced by a promissory note in such amount dated, and executed by Borrower in favor of Lender (the "Note"). The Note will be secured by a mortgage of the same date as the Note (the "Mortgage"). Lender and Borrower have requested that AmSouth execute this instrument.

AGREEMENT

In consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of all of which is hereby acknowledged, AmSouth agrees that the Mortgage shall be and remain at all times a lien or charge on the property covered by the Mortgage prior and superior to the lien or charge of the AmSouth Mortgage to the extent the Mortgage secures the debt evidenced by the Note and any and all renewals and extensions thereof, or of any part thereof, and all interest payable on all of said debt and on any and all such renewals and extensions, and to the extent of advances made under the Note or the Mortgage necessary to preserve the rights or interest of Lender thereunder, but not to the extent of any other future advances.

SUBORDINATION OF RECORDED FINANCING STATEMENT

Amsouth Bank, a state banking corporation, for good and valuable consideration, does hereby acknowledge and agree that its lien and security interest evidenced and secured by that certain UCC-1 financing statement bearing file no. 1997-18412, showing William S. and Gail B. Notwithstanding anything expressed or implied herein, AmSouth Bank does not in any way release, waive or subordinate the debt relating to or secured by the Financing Statement, or any portion thereof or payments thereon.

'The provisions of this Subordination Agreement are solely for the benefit of AmSouth Bank and the Mortgagee, and shall not be deemed to modify any of the agreements executed or delivered in connection with the Financing Statement or the Mortgage or to waive any of the rights of AmSouth Bank or the Mortgagee, as the case may be, thereunder as against the Debtor, nor shall it constitute or give rise to any defense, right of offset or counterclaim by the Debtor.
