The Birmingham NE Heat Sends ozone over limit

Rising mercury sent ground-level ozone over the federal limit Tuesday at the Hoover monitoring station.

The violation came despite a 3-year-old program to get the public to cut down on activities that contribute to air pollution in Jefferson

and Shelby counties.

The buildup of ozone is a side effect of heat, and this week's temperatures are the hottest of the year, causing record consumption of electricity Tuesday. Code red ozone alerts also have been issued for today and Thursday, when the temperature is expected to be 98 and 96.

While this week's weather isn't technically a heat wave by meteor-

ological standards, it has been the first prolonged blast of summer steam. Birmingham's high Tuesday was 94, and the heat index hit 104. The heat index, a factor of temperature and humidity, is expected to be 105 to 110 through the week.

Birmingham was close to meeting ozone standards until 1995, when record-breaking heat sent ozone levels well over the number allowed by CIRA. Last summer,

ozone levels did a repeat performance, ruining chances for the two counties to meet the standards until after 2001 no matter how well the area fares this summer.

Ozone is an odorless haze caused mainly when fuel fumes and emissions from coal-fired power plants and industries mix in the presence of sunlight. In high amounts, it can aggravate respiratory problems.

The Midwest and Northeast are

still being wracked by a heat wave with temperatures staying well above normal. At least 30 deaths have been blamed on those regions unusually hot weather in the past week.

The Jefferson County coroner's office said Monday's death of 62-year-old man at Jefferson State Community College was not heat related. He had a heart attack.
