CONSTRUCTION MORTGAGE

THIS MORTGAGE IS DATED JULY 16, 1999, between J. Harris Development Corp., whose address is 1109 Townhouse Road, Helena, Al. 35080 (referred to below as "Grantor"); and Regions Bank, whose address is 2964 Pelham Parkway, Pelham, Al. 35124 (referred to below as "Lendar").

GRANT OF MORTGAGE.
