MORTGAGE

THIS MORTGAGE IS DATED OCTOBER 23, 1988, between JONATHAN S. MAXSON and MARY A. MAXSON, HUSBAND AND WIFE, whose address is 117 KENTWOOD LANE, ALABASTER, AL. 35007 (referred to below as "Grantor"); and AmSouth Bank, whose address is 1849 Montgomery Highway, Birmingham, Al. 38244 (referred to below as "Lander").

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, grants, bargains, sells and conveys to Lender all of Grantor's right, title, and interest in and to the following described real property, together with all existing or subsequently erected or affixed buildings, improvements and fixtures; all easements, rights of way, and appurtenances; all water, water rights, watercourses and ditch rights functioning stock in utilities with ditch or irrigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar matters, located in SHELBY County, State of Alabama (the "Real Property"):

The Real Property or its address is commonly known as 117 KENTWOOD LANE, ALABASTER, AL 35007.

Grantor presently assigns to Lender all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property in addition, Grantor grants to Lender a Uniform Commercial Code security interest in the Personal Property and Rents.

DEFINITIONS. The following words shall have the following meanings when used in this Mortgage. Indebtedness. Hezardous Substances. The terms "hezardous wasts," "hezardous substance," "disposal," "release," and "threstened release," as deed in this Mortgage, shall have the same meanings as set forth in the Comprehensive Environmental Response, Compensation, and Lisbilly Act of 1980, as amended, 42 U.S.C. DUE ON SALE - CONSENT BY LENDER. Notice of Construction. Grantor will upon request of Lender furnish to Lender advance assurances satisfactory to Lender that Grantor can and will pay the cost of such improvements.
