1. ASSIGNMENT. In consideration of the loss or financial accommodation evidenced by the promiseory note or agreement described above, and all other present and future evidences of indebtedness, obligations, agreements, instruments, guaranties or otherwise of Borrower or Lessor (whether rouse than the premisentry note or agreement described above) and all renewals, extensions, amendments. modifications, replacements or substitutions to any of the fotegoing, (collectively the "Obligations") Lessor, identified above. PINNACLE BANK , 2013 CANYON ROLD, VESTAVIA, AL 35216 ("Lander") all Lessor's estate, right, title,

interest, claim and demand now owned or hereafter acquired in all excisting and future leases of all or any part of the real property described in Schedule A (the "Premises") (including extensions, renewals and sublemess), all agreements for use and occupancy of the Premises (all such bases and agreements whether written or ord, are hereafter referred to an the "Leases"), and all guaranties of leasess' performance under the Leases, together with the immediate and continuing right to estimat and receive all of the sents, income, receipts, revenues, leaves, profits and other income of any nature now or hereafter due (notuding any income of any nature naming due during any redemption period) under the Legess or from or arising out of the Premises including minimum rents, additional rents, percentage rents, parking or common area maintenance contributions, tax and insurance contributions, deficiency rents, liquidated demages following default in any Lease, all proceeds payable under any policy of insurance covering loss of rents resulting from untenantability caused by destruction or damage to the Premises, all proceeds payable as a result of a lesses's exercise of an option to purchase the Pramises, all proceeds derived from the termination or rejection of any Lease in a bankruptcy or other insolvency proceeding and all proceeds from any rights and claims of any kind which Lessor may have against any lesses under the Lesses or any occupants of the Premises (all of the above are herselfer collectively referred to as the "Rent"). This Assignment is subject to the right, power and authority given to the Lander to collect and apply the Rents. The Obligations described above are also secured by a mortgage or deed of trust to Lender on the real property described in Schedule A (the "Security Instrument"). The foregoing Assignment is intended to be specific, perfected, and choate and may be recorded as provided by applicable state law.

2. COVENANTS OF LESSOR. Lessor covenants and agrees that Lessor will:

observe and perform all the obligations imposed upon the landlord under the Leases;

b. refrain from discounting any future Rents or executing any future assignment of the Leases or collect any Pents in advance for more than one

c. perform all necessary steps to maintain the security of the Leases for the benefit of Lender Including, if requested, the periodic submission to

Lender of reports and accounting information relating to the receipt of Flant payments;

d. refrain from modifying or terminating any of the Leases without the written consent of Lender; a. execute and deliver, at the request of Lender, any assurances and assignments with respect to the Leases as Lender may periodically require.

f. comply with all applicable federal, state and local laws and regulations concerning the Premises, including but not limited to all environmental laws, the Americans with Disabilities Ast, and all zoning and building laws.

3. REPRESENTATIONS OF LESSOR. Lessor represents and warrants to Lander that:

a. the tenants under the Leases are current in all Flent payments and are not in default under the terms of any of the Leases;

b. each of the Leases is valid and enforceable according to its terms, and there are no claims or defenses presently existing which could be asserted by any tenant under the Leases against Lessor or any assignee of Lessor;

c. no Rents or security deposits under any of the Lesses have previously been assigned by Lessor to any party other than Lender; d. Lessor has not accepted, and will not accept, Rent in excess of one month in advance under any of the Leases;

e. Lessor has the power and authority to associate this Assignment; and

t. Lessor has not performed any act or executed any instrument which might prevent Lander from collecting Rants and taking any other action

4. LESSOR MAY RECEIVE RENTS. As long as there is no default under the Obligations described above, the Security Instrument securing the Obligations, or this Assignment, Lander grants Laccor a revocable license to collect all Rents from the Laccos when due and to use such proceeds in Lessor's business operations. However, Lender may at any time require Lessor to deposit all Pients into an account maintained by Lessor or Lender at

- 5. DEFAULT AND REMEDIES. Upon detault in the payment of, or in the performance of, any of the Obligations, Lander may at its option take possession of the Premiers, without becoming a mortgages in possession and have, hold, manage, lease and operate the Premiers on terms and for a period of time that Lender deems proper. Whether or not Lender has taken possession of the Premises, Lender may proceed to collect and receive all Rents, and Lender shall have full power periodically to make alterations, renovations, repairs or replacements to the Premises as Lender may deem proper. Lender may apply all Plants, in Lender's sole dispretion, to payment of the Obligations or to the payment of the cost of such alterations. renovations, repairs and replacements and any expenses incident to taking and retaining possession of the Premises and the management and operation of the Premises. Lender may keep the Premises properly insured and may discharge any taxes, charges, claims, assessments and other liens which may aconus. The expense and cost of these actions may be paid from the Rents received and any unpeid amounts shall be added to the principal of the Obligations. These amounts, together with other costs, shall become part of the indebtedness secured by the Security instrument and for which this Assignment is given.
- 6. APPOINTMENT OF RECEIVER. In the event of a default, Lender shall be entitled, without notice, without bond, and without regard to the adequacy of the collateral securing the Obligations to the appointment of a receiver for the Premises. The receiver shall have, in addition to all the rights and powers customarily given to and exercised by a receiver, all the rights and powers granted to Lender under the Security Instrument and this Assignment.

- 7. POWER OF ATTORISEY. Lessor irrevocably authorizes and appoints Lender as Lesson's attorney-in-fact coupled with an interest, at Lander's option, upon taking possession of the Premises to lesse or re-lesse the Premises or any part thereof, to cancel and modify Lesses, evict tenants, bring or defend any suits in connection with the possession of the Premises in the name of either party, make repairs as Lender deems appropriate and perform such other acts in connection with the management and operation of the Premises as Lender may deem proper. The receipt by Lender of any Rents under this Assignment after institution of forestosure proceedings under the Security Instrument shall not ours any default or affect such proceedings or sale which may be held as a result of such proceedings.
- a. INDEMNIFICATION. Lander shall not be obligated to perform or discharge any obligation, duty or liability under the Leases by reason of this Assignment. Leases thereby agrees to indemnify Lender and to hold Lender harmless from any and all liability, loss or damage which Lender may indur under the Leases by reason of this Assignment and from any and all claims and demands whatsoever which may be asserted against Lender by reason of any alleged obligations or undertailings on Lender's part to perform or discharge any of the terms or agreements contained in the Leases. Should Lander inour any liability, loss or damage under the Leases or under or by reason of this Assignment, or in the defense of any such claims or demands, the amount of such loss, including any costs and expenses to the extent permitted by applicable law, shall be secured by this Assignment and the Security Instrument. Lessor agrees to reimburse Lender immediately upon demand for any such costs, and upon failure of Lessor to do so, Lender may assesses and declare due all sums swed to Lender under any of the Obligations.
- 9. NOTICE TO TEMANTS. A written demand by Lender to the tenants under the Leases for the payment of Rents or written notice of any default claimed by Lender under the Leases shall be sufficient notice to the tenants to make future payments of Rents directly to Lender and to cure any default under the Leases without the necessity of further consent by Leaser. Leaser hereby releases the tenants from any Rebillty for any Rents paid to Lender or any action taken by the tenants at the direction of Lender after such written notice has been given.
- 10. INDEPENDENT RECORDS. This Assignment and the powers and rights granted are separate and independent from any obligation contained in the Security Instrument and may be enforced without regard to whether Lender institutes foreclosure proceedings under the Security Instrument. This Assignment is in addition to the Security Instrument and shell not affect, diminish or impair the Security Instrument. However, the rights and authority granted in this Assignment may be exercised in conjunction with the Security Instrument.
- 11. MODIFICATION AND WAIVER. The modification or waiver of any of Lessor's obligations or Lender's rights under this Assignment must be contained in a writing signed by Lender. Lender may perform any of Lessor's obligations or delay or fall to exercise any of its rights without causing a waiver of those obligations or rights. A waiver on one occasion shall not constitute a waiver on any other occasion. Lessor's obligations under this Assignment shall not be affected if Lender amends, compromises, exchanges, falls to exercise, impairs or releases any of the obligations belonging to any Lessor or third party or any of its rights against any Lessor, third party or colleteral.
- 12. NOTICES. Except as otherwise required by law, any notice or other communication to be provided under this Assignment shall be in writing and sent to the parties at the addresses indicated in this Assignment or such other address as the parties may designate in writing from time to time.
- 13. SEVERABILITY. Whenever possible, each provision of this assignment shall be interpreted so as to be valid and effective under applicable state law. If any provision of this Assignment violetes the law or is unenforceable, the rest of the Assignment shall remain valid.
- 14. MISCELLANIEOUS.
  - a. A default by Lessor under the terms of any of the Lessos which would entitle the tenant thereunder to cancel or terminate such Lease shall be deemed a default under this Assignment and under the Obligations and Security Instrument so long as, in Lender's opinion, such default results in the impairment of Lender's security.

Unless applicable law provides otherwise, Lessor consents to the jurisdiction of any court selected by Lander in its sole discretion located in the state indicated in Lander's address in the event of any legal proceeding under this Assignment.
