THIS MORTGAGE IS DATED AUGUST 6, 1999, between HPH Properties, Inc., a corporation, whose address is 2363 Lake Side Drive, Birmingham, Al. 35244 (referred to below as "Grantor"); and Regions Bank, whose address is P. O. Box 10247, Birmingham, Al. 35202 (referred to below as "Lender").

GRANT OF MORTGAGE. Personal Property. DUE ON SALE - CONSENT BY LENDER. Lender may, at its option, declare immediately due and payable all sums secured by this Mortgage upon the sale or transfer, without the Lender's prior written consent, of all or any pert of the Real Property, or any interest in the Real Property. Compliance With Laws. Grantor warrants that the Property and Grantor's use of the Property complies with all existing applicable laws ordinances, and regulations of governmental authorities.

Application of Net Proceeds.
